

# Rebates on Renewable Energy

## Application form

**Pre-approval is required to receive a rebate.** See the program guidelines for details on rebate amounts and eligibility criteria (available at [www.aea.nt.ca](http://www.aea.nt.ca)).

**Please note:** The Arctic Energy Alliance (AEA) is permitted to provide funding for renewable electricity projects only in communities that do not use hydroelectricity or in off-grid locations. Grid-connected renewable electricity projects in communities that use hydroelectricity are not eligible.

To receive your rebate, you must finish your project within 4 months of receiving pre-approval. Requests for extensions must be submitted to AEA prior to the 4-month deadline.

## Procedure

1. Fill in the applicant information below and the system information on the following pages.
2. Attach the following to your application:
  - a. A quote from your supplier or contractor, showing details of your system
  - b. A copy of your most recent power bill—only if you are installing a grid-tied renewable electricity system
3. Return your application to the AEA.

4. An AEA Energy Management Specialist will call to discuss your application.
5. Once your application has been pre-approved, complete your project within 4 months of your notice of pre-approval. If you need an extension, please submit your request before the 4-month deadline.
6. Within 1 month of finishing your project, submit to the AEA:
  - a. Final invoices and/or receipts showing your system is paid-for in full, noting the supplier, the date of purchase and itemized costs for materials.
  - b. Photos showing the system has been installed (see page 4 for a list of required photos)

## Consent to Collection and Disclosure of Personal Information

Your participation in the Alternative Energy Technologies Program (the “**Program**”) requires the Arctic Energy Alliance (“**AEA**”) to collect information from you, including your personal information. The AEA will collect your information, including your personal information, for the purpose of delivering the Program. All personal information collected from you by AEA is protected by the *Personal Information Protection and Electronic Documents Act, SC 2000, c 5*.
